Updated May 7, 2021 Testing and vaccination requirements are changing. EFFECTIVE IMMEDIATELY, fully vaccinated visitors may present their valid vaccination series in lieu of a negative COVID test result. (See more details below). In-person visits will expand to two hours starting May 22-23. Some institutions that weekend may also be eligible to increase the number of visitors per incarcerated person, depending upon public health criteria (See information below). Scheduling in-person visits is changing. Prospective visitors for weekend of May 22-23 MUST schedule in-person visits by emailing the institution directly. Requests can be sent starting May 15 at 8 a.m. (See the scheduling section below). Family visit details will be announced soon. Friends and family should regularly check the Facility Visiting Status page for updates on the status of in-person visiting at each institution. See additional details on the expanded phased approach to the visiting program below. One-hour video visits will continue at 33 participating institutions and 32 conservation (VSA). CDCR will be using VSA to schedule in-person visits now through Wednesday May 12, for visits May 15-16. After that time, CDCR will then require visitors to schedule in-person visits through email, to allow for greater flexibility. Institutions will begin to implement the email reservation process for in-person visits on May 15 for a visit to take place the weekend of May 22 and 23. We apologize for any confusion this may cause. CDCR recognizes visiting is an important way to maintain family and community ties. At the same time, our first priority is the health and safety of those who live in and work in our facilities. After suspending in-person visiting statewide in March 2020 at the onset of the COVID-19 pandemic health emergency, the department worked closely with our health care partners to begin reopening institutions for limited in-person visitation beginning April 10, 2021. The department has taken unprecedented steps to prepare and immediately respond to COVID-19, and active cases are the lowest they've been since early April 2020. On May 6, CDCR announced details of a three-phased visiting expansion that will allow facilities to increase the duration of each visit, and the number of visitors allowed to each incarcerated person, including children age 2 and older. In-Person Visiting CDCR is expanding its in-person visiting at 35 institutions as part of its Roadmap to Reopening. The department's plan is a phased and tailored approach anchored in guidelines and guidance from health care. Wardens and healthcare CEOs at each institution, based on the number of active cases, the time in between active and resolved cases, and other factors based on health and safety. All visiting will be determined based on availability and health and safety considerations. Please note—Some Institutions will be able to move to Phase III as early as May 22-23Two-hour in-person visitsThree visitors allowed for each incarcerated person – of these, two may be children age 2 or olderChild play areas will be available and sanitation protocols followedVending machines are not available Visiting hours vary, but most facilities will schedule video and in-person visits between 7 a.m. and 4 p.m. on weekends and holidays. Visiting slots will be limited based on space availability in accordance with COVID-19 safety protocols. All institutions will be following public health protocols while conducting visits, including the use of masks, physical distancing and sanitation of each station following a visit. CDCR will continue to enforce visitation rules including appropriate attire. Visitors are encouraged to reference our Frequently Asked Questions for how to schedule visits, and an overview of new protocols, including COVID-19 testing requirements. Vaccination/Testing Procedures In-person visitors who are unvaccinated MUST provide proof of a negative COVID-19 test taken no longer than 72 hours prior to admission into the institution. ON-SITE TESTING IS LIMITED AND NOT GUARANTEED. Find a testing location near you. Effective immediately, fully vaccinated visitors may present their valid vaccination card indicating they are at least two weeks past the last injection in their vaccination card as proof. These same rules apply to incarcerated people. In addition, incarcerated people are required to have a rapid response COVID-19 test 72-96 hours following their visit. Incarcerated people who decline the test will not be eligible for in-person visiting. Scheduling In-Person Visits at Institutions with Email Please submit requests via email, and include all necessary visitor information to the designated email of the facility for which you'd like to request a video visit. Only those individuals who have already been approved as a visitor may make an appointment at institutions or camps. Step-by-step instructions will be taken weekly, beginning each Saturday at 8 a.m. through Monday at 8 a.m. for visits the following weekend. Please note, emails received outside the timeframe allowed will not be rolled over to the following week reservation timeframe. Not all reservations may be accepted because of space and equipment limitations. Visitors must provide the following information in their visitation email request: Inmate CDCR NumberApproved Visitor(s) Full Name(s)Date of BirthValid Identification Scheduling Video Visits at Institutions using Visitation Scheduling Application (VSA) CDCR continues to offer real-time video visiting at 33 prisons and 32 conservation camps as a safe way for incarcerated people to see and speak with their loved ones. California State Prison – Corcoran and California State prison – Sacramento, are the only institutions not doing video visits at this time. VSA allows approved visitors to easily schedule their own visits and receive instant confirmation of their request. Requests for a visit can be made using VSA for a visit on the following weekend. For example, the scheduling window for a visit to take place on Sat. May 15 is from 12 a.m. May 7 through 11:59 p.m. May 11. For a visit on Sun. May 16, the scheduling window is 12 a.m. May 8 through 11:59 p.m. May 12. Additional institutions that will be using VSA for in-person and video visiting reservations will be announced in the coming weeks. Connectivity issues will not allow CDCR to offer VSA to schedule fire camp video visits. A step-by-step guide for how to use VSA is available on CDCR's website. Video Visiting Once connected to the Webex system, visitors should ensure they are in a location where they will be able to hear throughout the visit, as the incarcerated person's mask must remain on through the duration of the video visit. Before staff connects you to your loved one, approved visitors should log into the video visit at least five minutes prior to the scheduled start time and have valid identification ready to present to staff (including minor(s) birth certificates). To maintain order and to ensure safety, rules established in California Code of Regulations, Title 15, Article 7 Visiting, still apply during all video visits with the exception of dress code color restrictions. This also includes that there is absolutely NO recording of video visits. Any visitors caught violating these restrictions could have their visiting privileges suspended. Misconduct by any party during a visit will result in termination of the video visit. and may include disciplinary action. Information about attire and other visiting guidelines are available at . All institutions will be following physical distancing and sanitation of each station following a visit. Visit our website for additional information on CDCR's COVID-19 response. Visitors approved for video visitation will receive a confirmation email that includes the visit's time and date. The dates and times are assigned and cannot be changed if you cannot make the appointment. You may request a new visiting session during the next open visiting session during the next open visit of the visit's time and date. confirmation will be a link to join a visiting session as well as instructions on how to begin a video visit. You may also check out the Webex video visit. Scheduling Video Visits at Conservation Camps with Email CDCR has announced video visiting at 32 conservation camps, also known as fire camps. Friends and family may schedule visits starting at 8 a.m. on Saturday through 8 a.m. on Saturday through 8 a.m. on Monday for visits the following weekend. Please submit requests via email, and include all necessary visitor information to the designated email of the camp for which you'd like to request a video visit. As with all visitation at our institutions, visits may be canceled at any time for health and safety reasons. Inmate Family Councils Statewide Inmate Family Councils (IFC's) are a gathering of family and friends of the incarcerated who meet regularly with Wardens to support visiting since keeping strong family connections with loved ones is a powerful rehabilitative tool. These IFC's promote visiting by clarifying rules and regulations as well as discussing health, education, vocational training, packages, books, and related issues. Throughout the roll-out of the video visitation program, CDCR will be collecting feedback, questions, and concerns on the process from the IFC's so the department can work to create better solutions and processes for this new program.
