## Doj report on alabama prisons











The lawsuit came after the Justice Department said it had decided that the state would not fix its prisons through negotiations. "In the two years since the original notification to the state of the unconstitutional conditions of confinement, inmates at Alabama Prison for Men have continued to face a substantial risk of serious harm, including death, physical violence, and sexual abuse at the hands of other inmates". "Unconstitutional conditions are omn systemic in Alabama Men's Prisons", as evidenced by facility-level data and illustrated by examples of violence, sexual abuse, excessive force, and unsafe and unhealthy conditions." "The amended complaint, signed by United States Attorney General Merrick Garland, is attached at the end of this article. U.S. District Judge R. The Department of Justice says that unsafe conditions in Alabama's prisons have not improved in the two years since the Department of Justice first reported the status of its findings and that prisoner homicides have increased from already high levels. The Department of Justice filed an amended complaint to her lawsuit in the District Court of North Alabama on Wednesday. The ADOC said the original lawsuit included "a handful of specific charges at a limited number of facilities. The petitioners' isolated examples of inter-prisoner violence do not suggest a flagrant or flagrant violation of the Constitution", said the motion for dismissal. The amended DOJ lawsuit says that at least 55 men have been killed by other prisoners since October 2014. Ventress had the largest number, almost 1,000. In fiscal year 2019, about 278 inmates were transferred to outpatient hospitals for injuries sustained in assaults on other inmates, the Justice Department said. Ivey said she's still committed to new prisons. And the problem has worsened, with at least 16 men killed by other prisoners in fiscal year 2020, the Justice Department said. The complaint specifically mentions about 10 homicides over the past two years, including the stabbing death of 23-year-old inmate Ian Rettig, a day before he left the Fountain Correctional Facility.
